

This devotion is an excerpt from a Bible study as reported by Pr. Asad Masih from All India Masihi Jamat (AIMJ) titled "The Power Above All Powers." In this study, he addresses the Power of Me, the Power of We and the Power of He.

The Power of He (God)

There are different kinds of powers like physical, political, economical and electrical. Somehow, we don't talk much about God's power. In 2 King 6: 1-7, we see God's power in the form of a miracle when the ax head falls in the water. God always uses His power to help us and not destroy us. Jesus uses His power to help the people and His disciples, like when he feeds 5,000 hungry people.

Our God is not only the God of infinite power, but also the God of infinite compassion and tenderness. He is deeply touched by human needs. Now I want to remind you that God's power can turn impossible to possible. If he has the power to make the ax head float, then He also has the power to give you peace and victory over what you are going through right now. Are you in trouble because you do not have job, no business, no income and you are thinking about different ways of taking care of your family? I ask you, what is the problem that you have today? Always remember that our God is a miracle-working God. If we believe, we will see the glory of God. We will see the intervention of God. One Sunday, some school children said that "a miracle is something that you cannot do, but Jesus can." I highlight the miracle to remind us that He is God because He is good. So you can believe in God. God has also done miracles in my life. God's power is greater than the power of I, we or any other power in the world.

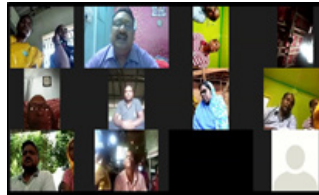

All India Masihi Jamat (AIMJ) praises God that they have been able to organize meetings and “camps” during the shutdown. On June 6, Baptism camps were held and 36 people were baptized. Six “seekers” meetings were held in which 73 people listened to God stories and sang songs. Five women’s meetings were organized and 68 women gathered to hear God’s word, worship and pray. Fifty-nine youth in total met across five youth gatherings, some via Zoom. They listened to Bible studies and worshiped.

Two children’s programs were held, and 28 children learned Bible stories and songs (pictured above).

Your contributions to Augustana District for AIMJ pay the salaries of four of the pastors involved in this work. These pastors earn \$125/month. God is making big waves in a nation of people of Hindu and Muslim faiths. We deeply appreciate your continued support for this ministry in India.

Worshiping On-line: The Connects and Disconnects

God's peace be with you.

The Augustana District Ambassadors have been meeting twice a month to mull over issues the shutdown has created for the church, specifically worship. The last meeting addressed the pros and cons of on-line worship. Worship may be live-streamed or pre-recorded, recorded with live people in house or only a preacher and a camera. The options vary but the concerns are similar across the board. We decided to share this conversation with you. We'll begin with the downside of on-line worship.

A major concern revolves around engagement in worship by the hearer. We know that God's Word is action and does what it says. Though minds wander during a service in the sanctuary, distractions at home seem to be endless. Sitting at home, do we truly become wrapped up in God's word and his promise or are we distracted with the string hanging from our pajama sleeve and the fact that our coffee has gotten cold? Can families sit quietly with children and stay mentally tuned-in to worship time? Do people even attempt to sit quietly to hear God speak and to worship him, or are we multi-tasking? What happens when the on-line connection is faulty?

If we worship on-line, do we mail in an offering? What happens to Sunday school attendance? Will the convenience of staying home be a temptation not to go physically go into God's house to worship the Almighty? Much controversy has swirled around digital communion and baptism — to administer the sacraments or not to administer them.

Other concerns circle around the process itself. In many cases, pastors have been tasked with the technical issues of recording, editing, uploading, etc. This has become an unexpected addition to

the calling of shepherding the flock. There is a call to upgrade video equipment and video quality. If up-loaded worship services are too professional, will anyone come to the church? Several pastors said the plan is to phase out live-streaming of worship. In addition, tracking "views" doesn't necessarily reflect people actively being attentive to worshipping God.

There are, however, positives to such worship options. Many churches have experienced large numbers of on-line attendees, some from afar and some who have decided to give offerings. So the "reach" of the church has expanded. Bible studies and text studies have gained a larger audience.

On-line worship is still a viable option for people who don't wish to risk close contact as disease numbers increase. Funerals and memorial services can be shared with distant family and friends who wouldn't otherwise be able to attend.

Like most things, there is an up-side and a down-side to on-line worship services. The concerns are real and revealing. Pastors are mindful about the hearts of the hearers, and the spiritual well-being of the church, the people of God. Extending the reach of the church is celebrated, but the lack of opportunity to quiet ourselves before the Lord and give time dedicated only to him can be detrimental to our over-all well-being. The gray area seems large and the line in the sand ever shifting. As you lift your pastor and church leadership in prayer, ask God's wise guidance surrounding these issues.

Masks will be requested at all three locations

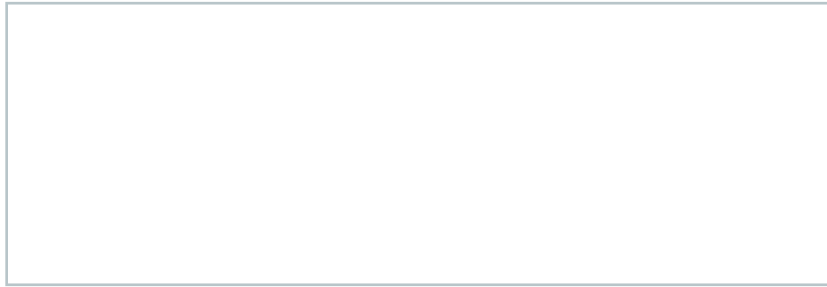
Social distancing will be observed at all three locations
